WHAT IS THIS PRODUCT?

Type

Investment Company (SICAV), Luxembourg

Term

This sub-fund has no maturity date. However, the board of directors may decide to close the sub-fund under certain circumstances.

Objectives

The sub-fund aims to generate a long-term capital growth by investing in interest bearing instruments such as bonds and money market instruments traded on a regulated market.

The investments primarily focus on issuers in the Nordic region.

The sub-fund may also invest up to 10% of its assets in other investment funds.

The sub-fund can use derivatives to achieve the sub-fund's investment objective or to reduce risks.

The sub-fund qualifies as an Article 8 product under SFDR (Sustainable Finance Disclosure Regulation) since its investment policy promotes environment, social, and governance characteristics ("ESG Goals"). The Investment Manager integrates these characteristics into its investment strategy to better manage risk and generate sustainable long-term returns. Further disclosures that describes the specific risks of investing in this sub-fund and investment strategies that are utilized by the Investment Manager to promote the sustainability characteristics are outlined in the prospectus or can be found on www.carnegiefonder.se.

Benchmark: The portfolio is actively managed on a discretionary basis without reference to a benchmark.

Intended retail investor

This fund may not be appropriate for investors who plan to withdraw their money within 3 years.

Other information

Depository: Skandinaviska Enskilda Banken. AB (publ) – Luxembourg Branch

Dividend income: This class is a capitalisation class meaning that income is reinvested.

Conversion right: The investor has the right to convert his investment in units in one sub-fund for units in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.

Segregation: The assets and liabilities of a sub-fund are segregated pursuant to the law so that the commitments and liabilities of one sub-fund do not affect the other sub-funds.

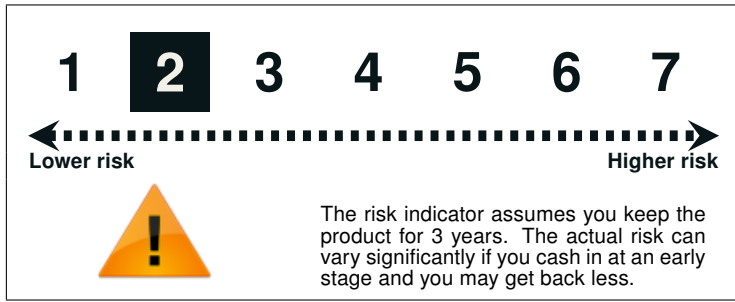

This sub-fund was launched in 1990 and this unit class in 2017.

The reference currency of the sub-fund is expressed in SEK. The currency of the unit class is expressed in CHF. For this unit class, the foreign-exchange risk of the unit currency is systematically hedged against the sub-fund's reference currency.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Risk indicator



The summary risk indicator is a guide to the level of risk of this product com-

pared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class. This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact our capacity to pay you.

Risk not captured by the risk indicator:

Liquidity risk: Low liquidity can make it difficult or impossible to buy or sell securities in reasonable time. Price may be lower or higher than expected.

This product does not include any protection from future market performance so you could lose some or all of your investment.

If we are not able to pay you what is owed, you could lose your entire investment.

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the product over the last 10 years. Markets could develop very differently in the future.

Unfavourable scenario: This type of scenario occurred for an investment be-

tween December 2021 and December 2022.

Moderate scenario: This type of scenario occurred for an investment between November 2015 and November 2018, by referring to a reference class.

Favourable scenario: This type of scenario occurred for an investment between February 2016 and February 2019, by referring to a reference class.

The stress scenario shows what you might get back in extreme market circumstances.

What happens if FundRock Management Company S.A. is unable to pay out?

The Management Company is responsible for administration and management of the sub-fund, and does not typically hold assets of the sub-fund (assets that can be held by a depositary are, in line with applicable regulations, held with a depositary in its custody network). The Management Company, as the manufacturer of this product has no obligation to pay out since the product design does not contemplate any such payment being made. However, investors may suffer loss if the sub-fund or the depositary is unable to pay out. There is no compensation or guarantee scheme in place which may offset, all or any, of this loss.

WHAT ARE THE COSTS?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding period we have assumed the product performs as shown in the moderate scenario
- 10,000 CHF is invested

(*) This illustrates how costs reduce your return each year over the holding period. For example it shows that if you exit at the recommended holding period your average return per year is projected to be 3.4% before costs and 2.1% after costs.

HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

Recommended holding period: 3 years

Redemptions are possible on each full bank business day in Luxembourg. In exceptional circumstances, your right to request the redemption of your investment may be limited or suspended.
