WHAT IS THIS PRODUCT?

Type

Investment Company (SICAV), Luxembourg

Term

This sub-fund has no maturity date. However, the board of directors may decide to close the sub-fund under certain circumstances.

Objectives

The sub-fund aims to generate a long-term capital growth by investing in a selection of other funds, which in turn invest in company shares and/or interest bearing instruments (fixed income), or in alternative funds investing in financial instruments. The targeted assets are other funds investing predominantly in the Nordic markets but might also hold assets in funds that are investing in other regions of the world, including in emerging markets.

The sub-fund invests in different types of other funds such as UCITS, UCI, exchange traded funds (ETFs) or alternative investment funds or Linked Investment Funds.

In pursuing this investment objective, the sub-fund follows a value investing strategy aimed at identifying funds investing in equities that are believed to be either undervalued or mispriced.

The sub-fund also invests its assets in fixed-income funds which are composed of high-yield corporate, money market instrument and investment grade bond funds.

As a general guideline and depending on the market conditions, the target asset allocation of the Sub-Fund is as follows:

- (i) between 40% and 80% of the assets invested in equity funds
- (ii) between 20% and 60% of the assets invested in fixed income funds
- (iii) up to 40% of the assets invested in alternative investment funds
- (iv) up to 30% of the assets invested in balanced funds

The sub-fund uses financial derivatives to achieve its investment objective or to reduce risks.

The sub-fund qualifies as an Article 8 product under SFDR (Sustainable Finance Disclosure Regulation) since its investment policy promotes environment, social, and governance characteristics ("ESG Goals"). The Investment Manager

integrates these characteristics into its investment strategy to better manage risk and generate sustainable long-term returns. Further disclosures that describes the specific risks of investing in this sub-fund and investment strategies that are utilized by the Investment Manager to promote the sustainability characteristics are outlined in the prospectus or can be found on www.carnegiefonder.se.

Benchmark: The portfolio is actively managed on a discretionary basis without reference to a benchmark.

Intended retail investor

This fund may not be appropriate for investors who plan to withdraw their money within 5 years.

Other information

Depositary: Skandinaviska Enskilda Banken. AB (publ) – Luxembourg Branch

Dividend income: This class is a capitalisation class meaning that income is reinvested.

Conversion right: The investor has the right to convert his investment in units in one sub-fund for units in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.

Segregation: The assets and liabilities of a sub-fund are segregated pursuant to the law so that the commitments and liabilities of one sub-fund do not affect the other sub-funds.

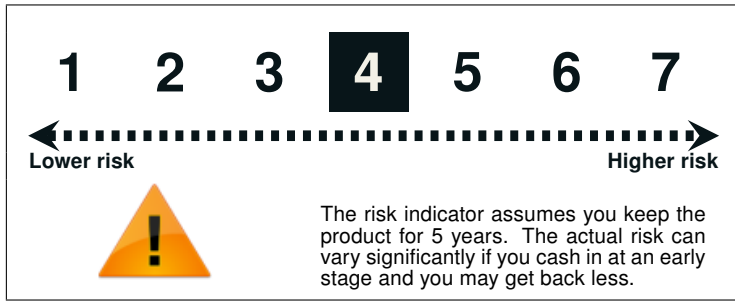

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you.

This product does not include any protection from future market performance so you could lose some or all of your investment.

If we are not able to pay you what is owed, you could lose your entire investment.

What happens if FundRock Management Company S.A. is unable to pay out?

The Management Company is responsible for administration and management of the sub-fund, and does not typically hold assets of the sub-fund (assets that can be held by a depositary are, in line with applicable regulations, held with a depositary in its custody network). The Management Company, as the manufacturer of this product has no obligation to pay out since the product design does not contemplate any such payment being made. However, investors may suffer loss if the sub-fund or the depositary is unable to pay out. There is no compensation or guarantee scheme in place which may offset, all or any, of this loss.

WHAT ARE THE COSTS?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding period we have assumed the product performs as shown in the moderate scenario
- 100,000 SEK is invested
