WHAT IS THIS PRODUCT?

Type

Investment Company (SICAV), Luxembourg

Term

This sub-fund has no maturity date. However, the board of directors may decide to close the sub-fund under certain circumstances.

Objectives

The sub-fund's investment objective is to invest as a Feeder Fund at least 85% in Carnegie Strategiefond (the "Master") (SE0000429813), a UCITS fund registered with the Swedish Act on Investment Funds open to private pension savings pursuant to the Swedish Individual Pension Savings Act.

Therefore the investment policy of the sub-fund shall be read in conjunction with the prospectus of the Master, the objectives and investment policy being the following: The investment objective is to invest its assets in transferable securities, money market instruments, fund units and accounts with credit institutions. The fund's assets must primarily be invested in Nordic or Nordic-related financial instruments. The fund's assets may also to a limited extent be invested in interest-bearing financial instruments with exposure outside the Nordic region. The Master is actively managed and does not have a benchmark index. Financial instruments are selected based upon individual assessments. The objective of the fund is to provide a maximum long-term return given the fund's level of risk.

The Master may invest a maximum of 10% of its value in fund units. The Master's assets may also be invested in transferable securities and money market instruments, up to a maximum of 10% of the value of its assets.

The Master may invest in derivatives. Derivatives may be used to improve the efficiency of the management and thereby increase the return and generate leverage. The Master may invest in OTC derivatives. The Master may make use of currency derivatives to partly or entirely hedge its holdings. The Master may enter into agreements regarding securities loans.

The sub-fund may invest a substantial portion of its portfolio in cash or cash related instruments at any time.

The sub-fund qualifies as an Article 8 product under SFDR (Sustainable Finance Disclosure Regulation) since Master's investment Policy promotes environment, social, and governance characteristics ("ESG Goals"). The Investment Manager integrates these characteristics into the Master's investment strategy

to better manage risk and generate sustainable long-term returns. Further disclosures describe the specific risks of investing in this sub-fund and what investment strategies are utilized by the Investment Manager to promote the sustainability characteristics as outlined in the prospectus or can be found on www.carnegiefonder.se.

Benchmark: The portfolio is actively managed on a discretionary basis without reference to a benchmark.

Intended retail investor

This fund may not be appropriate for investors who plan to withdraw their money within 5 years.

Other information

Depository: Skandinaviska Enskilda Banken. AB (publ) – Luxembourg Branch

Dividend income: This class is a capitalisation class meaning that income is reinvested.

Conversion right: The investor has the right to convert his investment in units in one sub-fund for units in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.

Segregation: The assets and liabilities of a sub-fund are segregated pursuant to the law so that the commitments and liabilities of one sub-fund do not affect the other sub-funds.

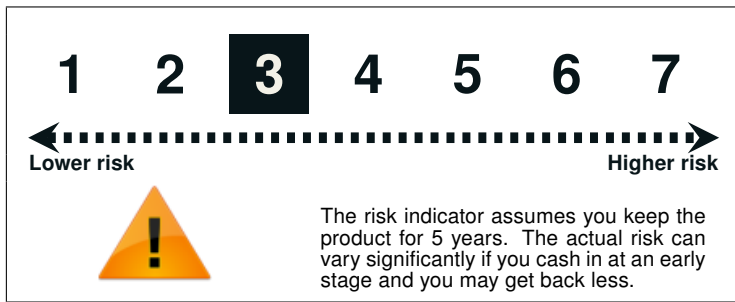

This sub-fund was launched in 1990 and this unit class in 2017.

The reference currency of the sub-fund is expressed in SEK. The currency of the unit class is expressed in NOK. For this unit class, the foreign-exchange risk of the unit currency is systematically hedged against the sub-fund's reference currency.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact our capacity to pay you.

This product does not include any protection from future market performance so you could lose some or all of your investment.

If we are not able to pay you what is owed, you could lose your entire investment.

Favourable scenario: This type of scenario occurred for an investment between December 2012 and December 2017, by referring to a reference class.

The stress scenario shows what you might get back in extreme market circumstances.

What happens if FundRock Management Company S.A. is unable to pay out?

The Management Company is responsible for administration and management of the sub-fund, and does not typically hold assets of the sub-fund (assets that can be held by a depositary are, in line with applicable regulations, held with a depositary in its custody network). The Management Company, as the manufacturer of this product has no obligation to pay out since the product design does not contemplate any such payment being made. However, investors may suffer loss if the sub-fund or the depositary is unable to pay out. There is no compensation or guarantee scheme in place which may offset, all or any, of this loss.

WHAT ARE THE COSTS?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding period we have assumed the product performs as shown in the moderate scenario
- 100,000 NOK is invested

HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

Recommended holding period: 5 years

You should be prepared to stay invested for 5 years. However, you can redeem your investment without penalty at any time during this time, or hold the investment longer. Redemptions are possible on each full bank business day in Luxembourg. In exceptional circumstances, your right to request the redemption of your investment may be limited or suspended.
