WHAT IS THIS PRODUCT?

Type

The fund is a UCITS fund pursuant to the Swedish Investment Funds Act (2004:46).

Term

This fund has no maturity date. However, the board of directors may decide to close the fund under certain circumstances.

Objectives

The fund is an equity fund that primarily invests in companies traded on the Swedish stock market. The fund also has the option to invest up to ten percent of the companies traded on the other Nordic stock markets.

The fund's investments are not targeted at any industry or type of company. The administration applies standards and guidelines for ethics and sustainability. The fund's investments are made in companies whose approach to the in the areas of social responsibility, environment, climate, corporate governance and business ethics is judged to serve as a future comparative advantage and value driver by being expected to positively impact profit growth and become more sustainable.

The objective of the fund is to achieve long-term capital growth, taking into account the fund's level of risk.

A maximum of 10% of the fund's assets may be invested in units in other funds.

Benchmark: The portfolio is actively managed on a discretionary basis without reference to a benchmark.

Intended investor

This fund may be suitable for savers who plan to hold their investment for at least 5 years and who are aware that the money invested in the fund can both increase and decrease in value and that there is no guarantee that the entire capital invested can be returned. No special knowledge or experience in investment funds or financial markets is required to invest in the fund.

Other information

Depository: Skandinaviska Enskilda Banken AB (publ)

Dividend income: This class is a capitalisation class meaning that income is reinvested. The unit class pays no dividends.

Conversion right: The investor has the right to convert his investment in units for units in the same fund. The investor can obtain information about how to convert in the prospectus of the fund.

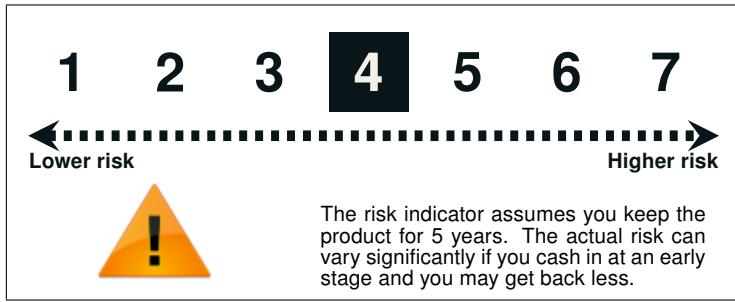

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you.

This product does not include any protection from future market performance so you could lose some or all of your investment.

Performance scenarios

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the product and of a suitable benchmark over the last 10 years. Markets could develop very differently in the future.

Unfavourable scenario: This type of scenario occurred for an investment between December 2021 and December 2022, by referring to a reference class.

Moderate scenario: This type of scenario occurred for an investment between

March 2013 and March 2018, by referring to a benchmark and to a reference class.

Favourable scenario: This type of scenario occurred for an investment between June 2016 and June 2021, by referring to a reference class.

The stress scenario shows what you might get back in extreme market circumstances.

WHAT HAPPENS IF CARNEGIE FONDER AB IS UNABLE TO PAY OUT?

If we are not able to pay you out what we owe you, you are not covered by any national compensation or guarantee scheme. To protect you, the assets are held with a separate company, the depositary Skandinaviska Enskilda Banken AB (publ). Should we default, the investments are liquidated and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.

WHAT ARE THE COSTS?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment. If the fund is part of another product, e.g. unit-linked insurance, there may be other costs for that product.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding period we have assumed the product performs as shown in the moderate scenario
- 100,000 SEK is invested

(*) This illustrates how costs reduce your return each year over the holding period. For example it shows that if you exit at the recommended holding period your average return per year is projected to be 10.7% before costs and 9.6% after costs.

HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

Recommended holding period: 5 years

You should be prepared to stay invested for 5 years. However, you can redeem your investment without penalty at any time during this time, or hold the investment longer. The fund is traded daily. Deposits into and withdrawals from the fund can normally be made on any weekday.
