WHAT IS THIS PRODUCT?

Type

The fund is a UCITS fund pursuant to the Swedish Investment Funds Act (2004:46).

Term

This fund has no maturity date. However, the board of directors may decide to close the fund under certain circumstances.

Objectives

The fund's objective is to generate daily return corresponding to 150% of the daily change of the OMX Stockholm 30 ESG Responsible Gross Index ("the index").

The objective means that if the index rises by 1%, the net asset value of the fund (NAV) will increase by 1.5% and if the index falls by 1%, NAV will decrease by 1.5%.

The fund buys equities and uses exchange-traded index futures to create exposure geared against the OMX Stockholm 30 ESG Responsible Gross Index. The fund's holdings are adjusted if the exposure against the index deviates from 150% of NAV by more than 5 percentage points.

The fund may invest its assets mainly in equity-related transferable securities, derivative instruments, fund units and deposits to accounts with credit institutions.

A maximum of 10% of fund assets may be invested in shares in other funds.

Benchmark: The portfolio is actively managed without reference to a benchmark.

Intended investor

The fund is suitable for the investor who believes that the Swedish stock market will have a strong development and who is aware of the risk of declines in the share value are high. The fund is suitable for a saver who plans to keep the investment in at least five years. The fund's daily leverage means that strong stock market fluctuations will have a negative impact on the fund's share value. No special knowledge or experience in investment funds or financial markets is required to invest in the fund.

Other information

Depository: Skandinaviska Enskilda Banken AB (publ)

Dividend income: This class is a capitalisation class meaning that income is reinvested. The unit class pays no dividends.

Conversion right: The investor has no right to convert his investment.

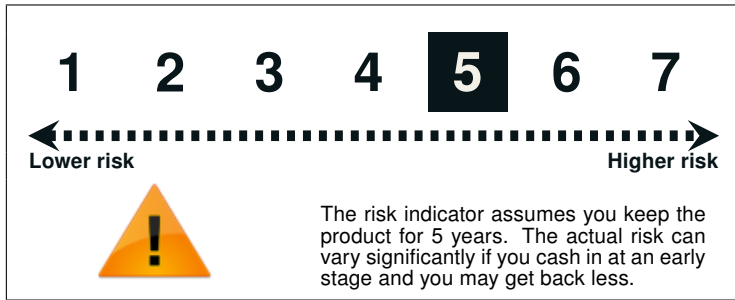

WHAT HAPPENS IF CARNEGIE FONDER AB IS UNABLE TO PAY OUT?

If we are not able to pay you out what we owe you, you are not covered by any national compensation or guarantee scheme. To protect you, the assets are held with a separate company, the depositary Skandinaviska Enskilda Banken AB (publ). Should we default, the investments are liquidated and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.

WHAT ARE THE COSTS?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment. If the fund is part of another product, e.g. unit-linked insurance, there may be other costs for that product.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding period we have assumed the product performs as shown in the moderate scenario
- 100,000 SEK is invested

HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

Recommended holding period: 5 years

You should be prepared to stay invested for 5 years. However, you can redeem your investment without penalty at any time during this time, or hold the investment longer. The fund is traded daily. Deposits into and withdrawals from the fund can normally be made on any weekday.
