### WHAT IS THIS PRODUCT?

**Type**The fund is a UCITS fund pursuant to the Swedish Investment Funds Act (2004:46).

This fund has no maturity date. However, the board of directors may decide to close the fund under certain circumstances.

**Objectives** 

The fund is an equity fund with a combined focus on global and Swedish equities. The fund invests with no restrictions as to company or sector.

The proportions of global and Swedish equities held by the fund may vary depending on market conditions, but the share of global equities is an estimated 70-90% over time.

The fund may invest its assets in transferable securities, money market instruments, derivatives, fund units and accounts with credit institutions.

The fund may invest a maximum of 10% of its net asset value in units in other funds or fund companies.

Investment in derivatives may be used to improve management efficiency as provided in chapter 5, section 12 (1) IFA. The fund may not use OTC derivatives as referred to in chapter 5, section 12 (2) IFA.

The objective of the fund is to generate a positive and stable return relative to investment risk.

Benchmark: The portfolio is actively managed without reference to a bench-

mark.

### Intended investor

This fund may be suitable for savers who plan to hold their investment for at least 5 years and who are aware that the money invested in the fund can both increase and decrease in value and that there is no guarantee that the entire capital invested can be returned. No special knowledge or experience in investment funds or financial markets is required to invest in the fund.

## Other information

Depositary: Skandinaviska Enskilda Banken AB (publ)

Dividend income: This class is a capitalisation class meaning that income is reinvested. The unit class pays no dividends.

Conversion right: The investor has no right to convert his investment.

## WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

### Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you.

Risks not captured by the risk indicator:

Currency risk: Currency exposure can potentially lead to a loss due to fluctuation in foreign currency.

This product does not include any protection from future market performance so you could lose some or all of your investment.

## WHAT HAPPENS IF CARNEGIE FONDER AB IS UNABLE TO PAY OUT?

If we are not able to pay you out what we owe you, you are not covered by any national compensation or guarantee scheme. To protect you, the assets are held with a separate company, the depositary Skandinaviska Enskilda Banken AB (publ). Should we default, the investments are liquidated and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.

## WHAT ARE THE COSTS?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment. If the fund is part of another product, e.g. unit-linked insurance, there may be other costs for that product.

#### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

#### We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding period we have assumed the product performs as shown in the moderate scenario
