### WHAT IS THIS PRODUCT?

#### Type

Investment Company (SICAV), Luxembourg

#### Term

This sub-fund has no maturity date. However, the board of directors may decide to close the sub-fund under certain circumstances.

#### Objectives

The sub-fund aims to generate a long-term capital growth by primarily investing in a diversified portfolio of interest bearing instruments (fixed income) of companies whose products or services contribute to attaining one or more of the 17 UN Sustainable Development Goals ('SDGs') mainly composed of High Yield Bonds and Floating Rate Note instruments of Nordic Corporate Bonds.

In order to achieve its objectives, the sub-fund shall invest its assets in fixed income securities, convertible bonds, fixed income related instruments, preferred shares and Payment-in-Kind (PIK) bonds of corporates having a higher credit risk and issued predominantly by companies that are domiciled or operating in the Nordic Markets (i.e. Sweden, Denmark, Norway, Finland and Iceland).

The sub-fund may invest up to 50% of its assets in listed instruments that are quoted on other regulated markets outside EU. The sub-fund may invest in Investment Grade Income instruments. The sub-fund may also invest in shares and similar instruments and/or holds company shares as a result of transactions involving securities or the conversion of convertible bonds.

The sub-fund may also invest up to 20% of its assets in Contingent Convertible Bonds (Coco's) and up to 10% of its assets in Asset-Backed Securities and Mortgage-Backed Securities (ABS' or MBS').

The sub-fund may use financial derivatives instruments (i.e. FX Forwards or Basis Swaps) to hedge against unfavourable Foreign Exchange, Interest Rate and Credit risks. From time to time, the sub-fund may invest a substantial portion of its portfolio in cash or cash related instruments.

The sub-fund qualifies as an Article 9 product under SFDR (Sustainable Finance Disclosure Regulation). The sub-fund's investment policy has environmental, social and governance characteristics. The Investment Manager integrates these characteristics into its investment strategy to better manage risk and generate sustainable long-term returns. To identify investments for the sub-fund, the Investment Manager uses a proprietary SDG framework that is part of the Investment Manager's model for sustainability analysis, CF THOR. **Benchmark:** The portfolio is actively managed without reference to a benchmark.

#### Intended retail investor

No special knowledge or experience in investment funds or financial markets is required to invest in the fund.

**Dividend income:** This unit class is a capitalisation class meaning that income is reinvested.

**Segregation:** The assets and liabilities of a sub-fund are segregated pursuant to the law so that the commitments and liabilities of one sub-fund do not affect the other sub-funds.

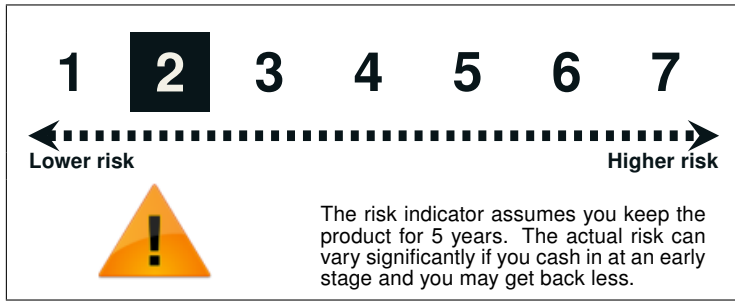

The currency of the sub-fund is SEK. The currency of the unit class is NOK. For this unit class, the foreign-exchange risk of the unit currency is systematically hedged against the sub-fund's currency.

## WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

### Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class. This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact our capacity to pay you.

## WHAT HAPPENS IF Universal-Investment-Luxembourg S.A. IS UNABLE TO PAY OUT?

## WHAT ARE THE COSTS?

### Costs over time

Deposits into and withdrawals from the fund can normally be made on any business day. In exceptional circumstances, your right to request the redemption of your investment may be limited or suspended.
