WHAT IS THIS PRODUCT?

Type

Investment Company (SICAV), Luxembourg

Term

This sub-fund has no maturity date. However, the board of directors may decide to close the sub-fund under certain circumstances.

Objectives

The sub-fund aims to generate a long-term capital growth by investing in a selection of funds, which in turn invests in equity and/or interest bearing instruments. The fixed income funds either invest in money market instruments, investment grade bonds or high-yield corporate bonds. The sub-fund also invests in alternative funds investing in financial instruments. The sub-fund primarily invests in funds investing predominantly in the Nordic markets, but might also invest in funds that are investing in other regions of the world, including emerging markets.

The sub-fund invests in different types of funds such as UCITS, UCI, exchange traded funds (ETFs) or alternative investment funds or Linked Investment Funds.

Below is the sub-fund's strategical asset allocation. The sub-fund mainly invests in equity funds to generate a long-term capital growth and fixed income funds to manage risk during turbulent times.

- (i) between 40% and 80% of the assets invested in equity funds
- (ii) between 20% and 60% of the assets invested in fixed income funds
- (iii) up to 40% of the assets invested in alternative investment funds
- (iv) up to 30% of the assets invested in balanced funds

The sub-fund uses financial derivatives to achieve its investment objective or to reduce risks.

The sub-fund qualifies as an Article 8 product under SFDR (Sustainable Finance Disclosure Regulation) since its investment policy promotes environment, social, and governance characteristics ("ESG Goals"). The Investment Manager integrates these characteristics into its investment strategy to generate sustainable long-term returns.

Benchmark: The portfolio is actively managed without reference to a benchmark.

Intended retail investor

This fund may be suitable for investors who plan to hold their investment for at least 5 years and who are aware that the money invested in the fund can both increase and decrease in value and that there is no guarantee that the entire capital invested can be returned. No special knowledge or experience in investment funds or financial markets is required to invest in the fund.

Dividend income: This unit class is a capitalisation class meaning that income is reinvested.

Conversion right: The investor has the right to convert his investment in units in one sub-fund for units in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.

Segregation: The assets and liabilities of a sub-fund are segregated pursuant to the law so that the commitments and liabilities of one sub-fund do not affect the other sub-funds.

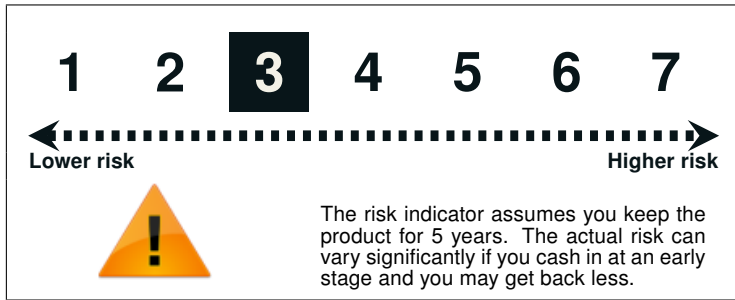

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact our capacity to pay you.

WHAT HAPPENS IF Universal-Investment-Luxembourg S.A. IS UNABLE TO PAY OUT?

WHAT ARE THE COSTS?

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding period we have assumed the product performs as shown in the moderate scenario
- 100,000 SEK is invested

Recommended holding period: 5 years

Deposits into and withdrawals from the fund can normally be made on any business day. In exceptional circumstances, your right to request the redemption of your investment may be limited or suspended.
