WHAT IS THIS PRODUCT?

Type

The fund is a UCITS fund pursuant to the Swedish Investment Funds Act (2004:46).

Term

This fund has no maturity date. However, the board of directors may decide to close the fund under certain circumstances.

Objectives

The fund is an actively managed equity fund which mainly invests in companies admitted to trading on the Swedish stock market. In addition to investments on the Swedish stock market, investments are also made in companies subject to trade outside of Sweden. The fund may invest up to 20% in companies admitted to trading outside of Sweden.

The fund may invest its assets in transferable securities, money market instruments, derivatives, fund units and accounts with credit institutions. Up to 10% of the total net assets may be invested in other funds or fund companies.

With investments on the Swedish stock market is meant that the fund invests its capital in companies that are domiciled in Sweden or companies listed on a Swedish marketplace or companies whose shares are traded on another market as long as the company's main business is located in Sweden.

The objective of the fund is to generate a return in excess of the value growth of the Swedish stock market over a period of 5 years.

Benchmark: The unit class is actively managed without reference to a benchmark.

Intended investor

This fund may be suitable for investors who plan to hold their investment for at least 5 years and who are aware that the money invested in the fund can both increase and decrease in value and that there is no guarantee that the entire capital invested can be returned. No special knowledge or experience in investment funds or financial markets is required to invest in the fund.

Other information

Depository: Skandinaviska Enskilda Banken AB (publ)

Dividend income: This unit class is a capitalisation class meaning that income is reinvested. The unit class pays no dividends.

Conversion right: The investor has the right to convert his investment in units for units in the same fund. The investor can obtain information about how to convert in the prospectus of the fund.

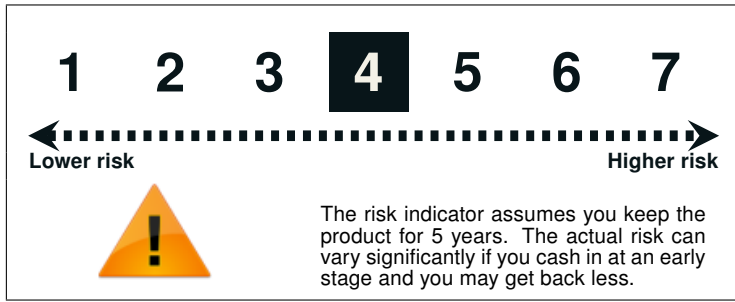

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you.

This product does not include any protection from future market performance so you could lose some or all of your investment.

Performance scenarios

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The figures shown include all the costs of the product itself, but may not include all the costs that you pay to your advisor or distributor. The figures do not take into account your personal tax situation, which may also affect how much you get back.

The unfavourable, moderate and favourable scenarios shown are illustrations using the worst, average, and best performance of the product and of a suitable reference class over the last 10 years. Markets could develop very differently in the future.

Unfavourable scenario: This type of scenario occurred for an investment between March 2015 and March 2020, by referring to a reference class.

Moderate scenario: This type of scenario occurred for an investment between April 2017 and April 2022, by referring to a reference class.

Favourable scenario: This type of scenario occurred for an investment between July 2016 and July 2021, by referring to a reference class.

The stress scenario shows what you might get back in extreme market circumstances.

WHAT HAPPENS IF CARNEGIE FONDER AB IS UNABLE TO PAY OUT?

If we are not able to pay you out what we owe you, you are not covered by any national compensation or guarantee scheme. To protect you, the assets are held with a separate company, the depositary Skandinaviska Enskilda Banken AB (publ). Should we default, the investments are liquidated and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.

WHAT ARE THE COSTS?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment. If the fund is part of another product, e.g. unit-linked insurance, there may be other costs for that product.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding period we have assumed the product performs as shown in the moderate scenario
- 100,000 SEK is invested

(*) This illustrates how costs reduce your return each year over the holding period. For example it shows that if you exit at the recommended holding period your average return per year is projected to be 11.0% before costs and 9.2% after costs.

HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

Recommended holding period: 5 years

You should be prepared to stay invested for 5 years. However, you can redeem your investment without penalty at any time during this time, or hold the investment longer. The fund is traded daily. Deposits into and withdrawals from the fund can normally be made on any business day.
